Evergrande Founder Ka Yan Jailed for Life

Hongkong: A Chinese court sentenced Chinese property tycoon Hui Ka Yan to life in prison for financial crimes linked to the collapse of his Evergrande real estate group.

The decision marks a milestone in Evergrande's saga after it de-



faulted on more than \$300 billion in liabilities when Chinese authorities cracked down on excessive borrowing in the real estate industry in 2020. That triggered a crunch among many developers and brought on a downturn in the property market.

Evergrande group was fined \$1.31 billion and Evergrande Real Estate Group \$1.04 billion. The Shenzhen Intermediate People's Court said Thursday it convicted 67-year-old Hui, who founded Evergrande, of engaging in large-scale financial fraud in inflating the group's assets and concealing its liabilities.

The court said Hui abused his position in orchestrating fraud and misappropriating company assets. "The amount involved is exceptionally large, the circumstances are particularly egregious, and extraordinarily heavy economic losses have been caused," it said. -AP

CASE: FB, INSTA 'TARGETING' CHILDREN

What if Meta Loses Trial? Cost: \$1.4 Tn = Company's Meap

Shares of Meta have been under pressure all year due to questions about its spending on artificial intelligence.

But a trial accusing its social media platforms of targeting children goes beyond that, raising existential questions about the future of its core business.

Meta, which owns Facebook and Instagram, is being sued by a bipartisan coalition of states on allegations of deceiving the public and designing the apps to encourage compulsive use among young users.

If it loses the trial, the company says it could face penalties of as much as \$1.4 trillion, which is roughly the size of its market capitalisation.

BUYING MICROSOFT'S AI TOOLS

Meta Platforms has become one of Microsoft's biggest AI customers, underscoring how demand for the emerging technology remains concentrated in the tech industry.

The social media company is spending hundreds of millions of dollars a year to access artificial intelligence models through Microsoft's Azure cloud service, according to a person familiar with the matter. Each week, Meta uses trillions of tokens—the unit of consumption for AI computing—via the platform, said the person, who requested anonymity to discuss an internal matter: -Bloomberg

TRUMP PROMISES... ... 'Economic Warfare & Isolation of Iran on Unprecedented Scale'

Washington | Dubai: US President Donald Trump warned of economic consequences against any country that provided "any type of lifeline to Iran" as the United States looks to resolve a war it began alongside Israel nearly six months ago.

In a social media message Wednesday, Trump promised "Economic Warfare and Isolation on an unprecedented scale," although details were scant. "ANY country that allows its financial institutions, businesses, airports, or government entities to provide any type of lifeline to Iran will itself face TREMENDOUS Economic Consequences," Trump wrote.

Iranian foreign minister Abbas Aragchi called Donald Trump's comments an attempt to divert American public opinion from domestic financial problems, including record debt and rising interest rates. "America's economic terrorism threatens the global economy and the national sovereignty of countries around the world," he

said on X.

CHINA CALLS FOR DIPLOMACY
China, meanwhile, said Trump's threat wouldn't work, urging cool heads to prevail. "Sanctions and pressure will not solve the problem," Chinese foreign ministry spokesman Lin Jian told reporters at a press brief-

ing. "China calls on all parties concerned to take responsible measures to resolve the issue through political and diplomatic means."
